Why we need to process your personal information...

• So we can establish the correct glass collection round details for your address and send to a text message to remind you to put your glass out on the correct day.

What information do we need to collect?

The information we collect includes; name, postal address and mobile telephone number.

We will use your information to;

- Establish your collection day based on your postal address.
- Send a text message to your mobile phone the evening before your scheduled collection.
- Send you text messages regarding emergencies situations that may affect our ability to collect your refuse, for example vehicle breakdowns or severe weather.
- Send you text messages about scheduled changes to refuse collections, for example public holidays such as Christmas & New Year.
- Communicate with you changes or updates to the Remind Me text messaging service.

We may need to share your information with our service providers, associated organisations and agents for the above purposes. We WILL NOT share your information with any external party for marketing or promotional purposes.

Who has access to your information?

New Forest District Council Waste & Recycling staff, ICT Department, and service software providers

How long will we keep your information?

We keep your data until you unsubscribe from the text messaging service.

How do you unsubscribe?

You can unsubscribe from the service by texting GLASS STOP to 81025. This will stop the text messages being sent, but will not remove your details from the Councils Remind Me database. If you wish to remove your data from the Councils database you can email remind.me@nfdc.gov.uk or contact customer services 023 8028 5000

Information we may collect from you whilst you are using our web services

We may collect information about your computer including your IP address, traffic data, location data, weblogs and other communication data operating system and browser type, for system administration. This is statistical data about our users' browsing actions and patterns.

For the same reason, we may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer.
